The accreditation cards will be handed out at the event office at Scandic Lillehammer Hotel. Please note that the accreditations will be approved according to the registrations in the FIS Entry. Those who have the FIS season accreditation can use this instead of the local accreditation.

Prices and rules:

- Booking according to the FIS Rules via FIS Online registration: https://www.fis-ski.com/DB/?authentication_page=signin
- The OC will cover accommodation costs according to the FIS World Cup rules
- The price for accommodation outside of the quota or for additional nights is CHF 125 per person in a double room (minimum number of persons occurs). The price for additional single rooms is CHF 160
- For nations with starting quota 4 or more the OC will cover two single rooms
- In case of extra single rooms inside the quota the cost difference between single and double room must be paid. However, in cases where single rooms will be necessary because of gender, role, number of athletes and staff inside the quota the OC will cover this.

Cancellation rules and fees:

- Cancellation fee between 8 days and until the end of the events: 100% cancellation fee.
- For cancellations of more than what is stated in the rules above the OC will charge a 100% cancellation fee.

- There will be a limited number of OC departures from/to the airport.

Alternative transportation (if no OC bus):

Train: Direct train (approx one departure every hour, except for in the night).

Shuttle to the venues:

• There will be shuttle service from the hotel to the venues. For shuttle times see the transportation desk at Scandic Lillehammer Hotel or at the hotel reception.

Travel money and payment:

- Travel money will be deducted from accommodation above quota and paid by bank transfer. Please send us updated bank information to silje.solbakken@olympiaparken.no
- Accommodation costs above quota: Teams will pay directly in the event office at Scandic Lillehammer Hotel. Only credit cards will be accepted.
- In case you are not able to pay by card, please send us your invoice information in advance.
- For teams that already know that all their accommodation is inside the quota, please send us updated bank information.

Prize money payment

Prize Money will be paid by bank transfer to the athletes after event. The prize money is regulated by the FIS Rules for World Cup. Receipts will be provided to the athlete electronically and a copy transmitted to FIS.

Income tax information for prize money

- Income tax of European citizens is 15%
- Income tax of non-European citizens is 15% (USA 0%)

 Tax will be deducted by the OC according to the Norwegian Foreign Artist Taxation Act, and taxes will be paid by the OC according to the regular tax legislation in Norway.

Waxing facilities

- Wax cabins are available from 16.11.2025 from 12:00 (TBC)
- The keys to the cabins are available at the lift station at the venue. Please remember to return all keys.
- Wax cabins for SRS companies according to World Cup rules.









Team Catering

Costs for lunch service at venue is CHF 10 per person per day for over quota or if you haven't ordered and paid full board via the Organising Committee. Opening hours to be announced at TCM.

Regulations of radio equipment/radio frequencies

The import, export and the operation of radio equipment in Norway is regulated by national law. Permits for the use of radio transmission equipment must be requested according to national specifications.








Arena Map
